DR. CHARLES R. ARDIS LEAVES A LEGACY OF DIGNITY AND EXCELLENCE

RDDS member Charles R. Ardis, who passed away at the age of 94 last year, led a life of personal generosity, professional excellence and compassion, and genuine philanthropy. In addition to his **MANY** contributions to his beloved

community, Dr. Ardis has left a legacy to dentistry. This legacy continues with the establishment of two important endowments set up by Dr. Ardis and his closest protégé, member dentist Dr. Mike Lueder. These endowment agreements will be managed by the Cadillac Area Community Foundation.

The first endowment is entitled the "Dr. Charles R. Ardis Memorial Restricted Endowment for Continuing Education for Dental Health Professionals Fund." This was established via a \$50,000.00 gift from his estate to help pay for the annual Dr. Charles R. Ardis lecture series to be put on by the Resort District Dental Society. Our first lecture in this series will be Dr. John Kois in June of 2006. This annual lecture series will feature high quality speakers and educational opportunities to honor Dr. Ardis' lifetime achievements of excellence.

The second endowment was funded by both the Ardis Estate and Dr. Lueder and is known as the "Ardis/Lueder Northern Lower Michigan Endowed Scholarship Fund. This was established by a combined gift of \$100,000.00 from Drs. Ardis and Lueder. This scholarship is specific in that it is available to students from Wexford, Missaukee and Osceola Counties attending dental school at the University of Michigan. Dr. Mike Lueder is continuing Dr.

Ardis' tradition of generosity and we are lucky to have had such leaders as our colleagues. These gifts will benefit the dental profession for many years to come – a legacy we can all be proud of.

MINUTES FROM RDDS BUSINESS MEETING

Meeting was called to order at 9:27 A.M. with introductory remarks by RDDS President, Dr. William Northway. Dr. Northway introduced Dr. Tom Veryser of Dental Clinics North. Dr. Veryser gave a detailed lecture about the operations of Dental Clinics North, issues affecting Medicaid dental care, and organized dentistry's role in the care of the underserved.

Dr. Vincent Mack, our regional MDA Trustee, spoke of issues affecting our association and membership at the state level and solicited more involvement from our members. Dr. Mack encouraged those who are interested in representing our society as Delegates to contact the RDDS Officers. Dr. Mack is stepping down from his position

as Trustee. His great contributions to organized dentistry were applauded. Dr. Rob Lovell has been named as the new Trustee for our region. He will make his debut at the MDA Annual Session.

Dr. Sara Bergsma gave her report on New Members and Membership. The New Member outing was a success last May, and Dr. Bergsma recommends that we continue to hold similar functions annually. There is an opportunity for a representative to attend a workshop on New Dentist Membership in Chicago in June of 2005. Dr. Bergsma inquired if there were sufficient funds to sponsor such a trip. RDDS officers to discuss funding in April.

Dr. Scott Schulz, RDDS Treasurer/Secretary, gave an overview of RDDS financial operations for the fiscal year (April 2004-April 2005). Our CE events and dues for the year have more than paid for the expenses of the RDDS, and we returned a positive balance for the fiscal year. Dr. Schulz recommended keeping dues at their current level of \$45, already one of the lowest in the state. The RDDS AGD PACE application has been approved for administration of continuing education until September, 2008. Dr. Dan Coté, RDDS President Elect, gave his report on the Scientific Program. Citing a successful year, he proposed to follow a similar schedule for 2005/2006. Meetings will tentatively be scheduled in May, Sept, Oct, Dec, Jan, Feb, April

and June. The officers will convene in April to develop the year's schedule. Any input or requests are welcome. Please contact President Dan Coté.

The RDDS bylaws were brought before the members by Dr. Lovell for vote. A motion was made by Dr. Mack, seconded by Dr. Portenga, and a unanimous decision was made to ratify and accept the new bylaws.

Dr. Mike Lueder gave his report on the RDDS Continuing Education Fund. The fund was started with a generous gift from Dr. Charlie Ardis. In addition to scholarships for worthy dental school students, the fund may also provide funding for RDDS CE events. A motion was made by Dr. Lovell to name an annual RDDS CE lecture in honor of Dr. Ardis. The motion was seconded by Dr. Rathke and accepted unanimously. The first lecture to bear his name will be the June 29, 2006 lecture with Dr. John Kois.

The agenda for 2005-06 was discussed. Dr. John Kois is scheduled for June 29, 2006. Dr. Bob Portenga and Dr. Tom Littlefield will again host the RDDS annual golf outing. The date is set for September 9, 2005.

Election of Officers

By unanimous decision Dr. Wayne Olsen was named President-Elect, Dr. Scott Schulz was named Treasurer/Secretary, and Dr. Brian Rathke appointed Editor for 2005-2006. Dr. Dan Coté will assume duties as President immediately. Dr. Rathke petitioned anyone who may have an interest in the editor

position to contact him immediately.

Thank you Dr. Northway for all you have contributed to the RDDS!
